



CM102: Dynamics of Working with Justice-Involved Persons

Course Description

This course designed to understand the corrections environment, people and culture. Common characteristics of justice-involved people, the specialized approaches to ministering within corrections and reentry, and Biblical perspective for transformation are examined. Special attention is given to the psycho-sociological factors that contribute to criminality, the pains of incarceration, the population, cultural competency, behavior change, and evidence-based and faith-based programs.

Course Objectives

Upon completion of the course, students should be able to do the following:

- A. Assess the pathways and variables within the psychological make-up and sociological backgrounds of the justice-involved and identify programs and demonstrate skills leading toward rehabilitation.
- B. Describe unique characteristics, attitudes, and behaviors of the justice-involved, life behind bars and the pains of imprisonment, and propose compassionate, culturally intelligent ministry approaches.
- C. Describe the behavior change process, how to facilitate healing and behavior change.
- D. Integrate evidence-based practices and faith-based programming to facilitate rehabilitation.
- E. Demonstrate motivational interviewing.

Academic Honesty

If the plagiarism is deemed unintentional, the student will have an opportunity to resubmit the work with a grade penalty. **Misrepresentation:** giving the impression of having done more significant work than you actually did (e.g., padding references with works not consulted, doing less than your fair share of a group project, or recycling one's own work).

Disciplinary responses will be individualized to reflect the maturity of the student, the severity of the infraction and any evolving patterns.

Course Requirements

This course consists of two virtual meetings, readings, mentor meetings, lecture videos, quizzes, group discussions, and assignments. The information regarding these course components and expectations is as follows:

Virtual Meetings. The two virtual meetings are Monday, January 3, 2022 at 6:00 pm (Central) and January 31, 2022 at 6:00 pm (Central). Links and information will be emailed to you.

Readings. Reading assignments should be read in the module in which they are assigned.

Mentor Meetings. Meet with your mentor in-person or by phone two times to share what you are learning and hearing from God. This mentor does not have to have correctional ministry experience. Submit your Mentor Meetings Report Form by **February 27, 2022.**

Lecture/Videos. Each module will include lecture/videos from the instructor or field experts.

Quizzes. Each module includes a 25-question, multiple choice quiz over the readings and lectures for that module.

Discussion Forums. Discussion questions are provided in each module. The Discussion Forum for each week begins on Monday at 12:01 a.m. Central Standard Time (CST), and your first post is required by Wednesday each week. All posts must be submitted prior to the following Sunday at 11:59 p.m. CST. You are required **to post an initial response and respond to two other posts** (total of 24 posts for the course). Option B. Read a credible article about the special population and provide a 1-2 page summary/ministry application.
